### **Warranty for All Types of Tubs**

The construction of your tub is covered for repair or replacement, as determined by JetstreamWorks. To the original owner of the bath, JetstreamWorks will repair or replace tub for 3 years.

The finish of your tub for appearance is covered for repair or replacement, as determined by JetstreamWorks. To the Original owner the warranty period, with normal use is as follows:

Acrylic tubs surface, vacuum formed - 3 years.

Gelcoat sprayed tubs - 3 years.

Painted surfaces on cast iron or acrylic tubs - 1 year.

Poured or cast solid surface tubs - 3 years.

Porcelain on cast iron - 3 years.

The equipment used in your bath such as pumps, blowers, heaters, jets, pipes, fittings, glues, adhesives, silicone and sealers is warranted by the OEM supplying the materials. JetstreamWorks will extend the OEM warranty period to your bath.

#### **EXCLUSIONS:**

Misuse or abuse of bath, or exposure to chemical or abrasives

There are no other warranties, expressed or implied in any way.

Normal wear and tear from use of your bath

Removal or installation cost related to a warranty claim

Repair or attempt to repair by unauthorized company

### **Three Year Limited Whirlpool System/Air Bath System Warranty**

**JetstreamWorks, LLC** extends to the original purchaser and any subsequent owner a limited warranty on its whirlpool bath or air bath against defects in the whirlpool system or air bath system which affect the performance of the unit as a bathing fixture for a period of five (3) years from the date of purchase.

This unit is warranted against original defects in the whirlpool system, provided that the unit has not been abused, taken apart, or tampered with in any way whatsoever. Should the unit be other than warranted during that 3 year period, **JetstreamWorks, LLC** while, at its option (after inspection and verification of the claimed defect) either repair the unit or supply a replacement of comparable size and color without charge for the unit, but excluding any costs of removal or installation or shipping/delivery.

Repair, or replacement unit under this warranty shall be the exclusive remedy of the owner. **JetstreamWorks, LLC** shall not be liable for any incidental or consequential damages, including any damage to the building, its contents or occupants, or for the breach of any express or implied warranty.
